Conditions of Entry: Please ensure you are willing to comply with the following Conditions of Entry before you enter this NADEC competition. Your Signature is required on this entry form (where provided for) to acknowledge that you have read these rules and will abide by them.

- This NADEC event is to be conducted under EFA Rules
- Welfare of the Horse - FEI Code of Conduct - **Observed mistreatment or abuse of a horse will not be tolerated.** NADEC will take appropriate action as deemed necessary against those competitors that choose to disregard the rules pertaining to the welfare of the horse and the FEI code of conduct.
- All riders must wear an ASA approved helmet (AS/NZS 3838:1998 Current Australian Standard) at all times while mounted on a horse. NO helmet = NO ride
- Non-NADEC members & Non-EFA members - Must complete the Unregistered Rider Waiver (URW) This form must be forwarded together with the Associate entry forms and an **additional \$20 is payable with the entry fees.**
 (NB: A Non-Member is a person who wishes to participate in this competition but is not a direct member of the EFA or NADEC. Upon completion of this Associate entry form and also completion of the URW and payment of the additional \$20 insurance the rider will be deemed to be a NADEC member during the competition for the purposes of participation only).
- Maximum number of classes per horse is 3, over two consecutive levels at or above the horse's EFA graded level.
 Horses competing below their graded level must compete HC and will be reserve listed if class is full
- Horses with an EFA grading may only compete at their graded level or one level above.
- NADEC reserves the right to return incomplete and/or incorrect entries or entries with incorrect payment. CHECK YOUR ENTRIES
- NADEC reserves the right to alter or cancel any section of this event/competition program or to cancel this event/competition
- No refunds after close of entries without provision of a Vet or Medical certificate which must be supplied within 5 working days from the competition date.
- Should this event/competition be cancelled entry money will be refunded after a deduction has been made for administration fees.
- Riders under the age of 16 must have a parent or guardian present on the grounds at all times on the day of the competition.
- No electric or rope yards are permitted at any NADEC competition.
- Dogs must be leashed at all times
- NADEC will not accept late or faxed entries. Neither NADEC, nor any of its' Committee Members will accept any responsibility whatsoever for delays which may be incurred by Australia Post resulting in entries not meeting the *close of entry* deadline nor for any entries that may be lost by Australia Post.
